

APPLICATION FOR PRE-BAR EXAMINATIONS – JANUARY 2025

Pursuant to the provisions of the Kenya School of Law Act, 2012, the Kenya School of Law (Training Programmes) Regulations, 2015, the Council of Legal Education (Kenya School of Law) Regulations, 2009 and various decisions of the High Court of Kenya, the Kenya School of Law hereby invites eligible persons who wish to be considered for admission into the 2024 Advocates Training Programme(ATP) to apply for the **January**, 2025 Pre-Bar Examinations.

1. ELIGIBILITY:

- i) Category A: Graduates of <u>Foreign</u> Universities who were admitted into the LL.B programme <u>AFTER</u> 8th December 2014;
- ii) Category B: Graduates of <u>Local</u> and <u>Foreign</u> universities admitted into the LL.B <u>BEFORE</u> 8th <u>December</u>, 2014 and who fall under <u>paragraph</u> 5(d), <u>Part A</u>: Il of the 1st <u>Schedule</u> to the Council of Legal Education (Kenya School of Law) Regulations, 2009.

2. <u>TIMETABLES:</u>

i) CATEGORY A - KENYA SCHOOL OF LAW ACT, 2012

The examination shall be held on **MONDAY**, 6TH **JANUARY 2025** at the <u>Kenya School of Law, Lang'ata South Road</u>, <u>Karen</u>. The examination shall test an applicant's mastery of general principles of law, legal techniques, language of the law and proficiency in English.

ii) CATEGORY B - COUNCIL OF LEGAL EDUCATION (KENYA SCHOOL OF LAW REGULATIONS) 2009

The examination shall be held from MONDAY 6TH JANUARY 2025 to WEDNESDAY, 8TH JANUARY 2025 at the Kenya School of Law, Lang'ata South Road, Karen. The examination shall test the mastery of basic legal techniques, legal writing and substantive legal principles at the degree subject level. It will also test applicants' proficiency in English language.

NB: Personal cheques and cash shall not be received by the School.

The application form must be returned together with:

- a) Copy of the applicant's LL.B. degree certificate or proof of eligibility for conferment;
- b) Copies of academic transcripts for the four (4) academic years; NB. (*Provisional transcripts shall only be accepted if they show proof of completion of the LL.B programme*)
- c) Copy of admission letter to the LL.B programme;
- d) Proof of payment of the examination(s);
- e) Copy of secondary school certificate(s);
- f) Copy of national identity card or valid passport;
- g) Two passport size colour photographs;
- h) Copy of CLE clearance letter for persons with LL.B Degrees from **foreign** universities;
- i) Letter of equation from any institution lawfully mandated to equate secondary school qualifications in Kenya for secondary school qualifications not offered by KNEC.
